

Terms & Conditions for PrayagEdu Mobile & Web App Users

Welcome to **PrayagEdu**, a mobile & Web application owned and operated by **Iewduh Techz Private Limited** (“Company”, “We”, “Us”, or “Our”). By downloading, installing, accessing, or using the PrayagEdu mobile & Web application (“App”), you (“User”, “You”, “Your”) agree to be bound by these Terms & Conditions (“Terms”). If you do not agree to these Terms, please do not use the App.

1. Eligibility

- You must be at least **14 years old** or have permission from your parent/guardian or school authority to use this App.
- Use of the app by students is considered to be under the supervision of their parents/guardians or school.

2. Purpose of the App

PrayagEdu is a **School ERP Mobile & Web Application** that provides educational institutions, parents, teachers, and students with features including (but not limited to):

- Attendance tracking
- Homework/assignments
- Timetable & academic calendar
- Examination marks & report cards
- Communication between school and parents
- Fee management and payment reminders
- Transport tracking (if enabled by the school)
- Notice board & announcements

The App does **not** function as an independent service. Access and features depend on your school’s subscription and permissions.

3. User Account & Login

- Your login credentials are provided by your school or institution.
- You are responsible for maintaining the confidentiality of your username and password.
- Any activity performed using your credentials will be assumed to be done by you.
- Notify your school or our support team immediately if you suspect unauthorized access.

4. Data Collection & Privacy

By using PrayagEdu, you agree to the processing of your personal data as outlined in our **Privacy Policy** (<https://prayagedu.com/privacy>)

The App may collect data including:

- Student profile information
- Attendance data
- Academic records
- Communication logs
- Device information for app functionality
- Location data for Attendance & transport module (if applicable)

We do **not sell**, rent, or trade your personal information. Data is used only for school management operations and app functionality.

5. Responsibilities of the User

You agree that:

- You will use the App only for lawful, educational purposes.
- You will not attempt to hack, reverse engineer, exploit, or damage the App.
- You will not misuse communication features to send harassment, threats, or inappropriate content.
- You will not upload false documents or attempt to manipulate academic/attendance data.

Violation may result in suspension or permanent termination of your access.

6. School's Control Over Data

- The school/institution linked with your account has full authority over your data.
- Deletion, correction, or changes to information must be requested through your school.
- The school controls which features you can access.

We are a **technology provider**, not the owner or controller of academic or attendance records.

7. Fees & Payments

- App usage is generally included in your school's subscription.
- Any fee payment feature (if enabled) is based on the school's configuration.
- We are not responsible for payment disputes, late fees, or incorrect billing by the school.

8. Communication & Notifications

The App may send push notifications, SMS, or emails regarding:

- School announcements
- Homework or academic updates
- Attendance alerts
- Fee reminders
- Transport updates

You can disable notifications in your device settings, but you may miss important updates.

9. Intellectual Property Rights

- All content, design elements, logos, icons, images, and software components of PrayagEdu are the intellectual property of **Iewduh Techz Private Limited**.
- You may not copy, distribute, modify, or reproduce any part of the App without written permission.

10. Third-Party Services

Some features may integrate with third-party tools or payment gateways.

We are not responsible for:
